STANDARD BUSINESS SOLUTIONS	
DESCRIPTION	This program provides rebates for common energy efficiency measures, including high-efficiency lighting, HVAC, building envelope, compressed air and refrigeration equipment, as well as select sensors and controls.
WHAT QUALIFIES	Measures must meet equipment catalog/program guidelines: <ul style="list-style-type: none">• Lighting• Lighting controls• HVAC• Energy management systems (EMSs)• Variable-frequency drives (VFDs)• Building envelope (window film/shade screens), cool roof coating, roof/ceiling insulation• Compressed air equipment• Refrigeration equipment and controls• Building controls• IT and data center equipment• Kitchen equipment• Pool pump VFDs• Heat pump water heaters
REBATES	<ul style="list-style-type: none">• Interior lighting: \$0.25-\$0.35 per watt (W) reduced• Interior lighting controls: up to \$0.40 per watt controlled• Exterior lighting: \$0.15 per W reduced• Unitary heat pumps: \$110-\$135 per ton• Variable-frequency drives: \$90-\$300 per horsepower (hp), depending on application• Building envelope: \$0.75 to \$0.80 per square foot for window film and shade screens• Refrigeration, compressed air and data center equipment: varies• HVAC controls: (sensors, thermostats and advanced rooftop controls) varies• Energy management systems: \$0.20-\$0.30 per square foot of conditioned space• Additional HVAC opportunities available, incentives vary• HE server replacement (retro) and server virtualization
WHEN TO APPLY	<p>Lighting retrofit: Preapproval is required prior to purchasing, ordering or installing.</p> <p>Other measures: Post-purchase is allowed. Retrofit and new construction projects are eligible.</p>
KEY BENEFITS	<ul style="list-style-type: none">• Lower electric bills• Lower initial cost• Less downtime and fewer repairs• Lower maintenance costs• Improved comfort in the workspace

CUSTOM BUSINESS SOLUTIONS	
DESCRIPTION	This program offers the flexibility to identify and implement energy efficiency projects unique to a facility and its operations. If energy savings can be measured, the project probably qualifies. Preliminary assessments are available to qualifying customers to help identify energy-saving opportunities.
WHAT QUALIFIES	<p>Most equipment that reduces annual energy consumption and energy consumption during SRP's summer peak period is eligible. Equipment must not be eligible for a rebate under the Standard program.</p> <p>EXAMPLES:</p> <ul style="list-style-type: none"> • Central plant controls optimization • Compressor replacements in chillers • Upgrading refrigeration compressors and condensers • Conversion from constant air volume to variable air volume • Improvements to the building envelope <p>PRELIMINARY ASSESSMENTS ARE AVAILABLE FOR:</p> <ul style="list-style-type: none"> • Receive electrical service on a qualifying E-60 series rate plan • Non-HVAC pumping systems with at least 25 hp, excluding backup • Data centers larger than 1,000 square feet • Compressed air system leak assessment between 25 and 100 hp
REBATES	<ul style="list-style-type: none"> • Equipment: \$0.08 per kilowatt-hour for the first year of electricity savings plus \$300 per average peak kW saved, up to 75% of the incremental custom cost • Pump assessment: Up to \$500 per pump, with a max of \$3,000 • Compressed air system leak assessment: 100% up to \$25 per hp • Preliminary assessment: 100% funded up to \$3,000 • Technical assessment: 50% of the preapproved cost, up to \$15,000; 100% (up to a maximum of \$30,000) if suggested improvements are made
WHEN TO APPLY	<p>Retrofits: Preapproval is required prior to purchasing, ordering or installing.</p> <p>New construction and end-of-useful life replacements: Post-purchase is allowed, but customers proceed at risk of not receiving a rebate.</p>
