Dear Mr. Randolph,

On May 1, 2001, the Commission granted SRP a Certificate of Environmental Compatibility (CEC) for the Santan Expansion Project in Decision Number 63611. Condition 39 of the CEC Decision 76764 requires that "Applicant shall annually provide \$20,000 to the Pipeline Safety Revolving Fund until 2020, thus improving the overall safety of pipelines throughout the State of Arizona".

In our continued compliance with that provision, SRP is submitting a check for \$20,000, made payable to the Arizona Corporation Commission, for deposit in the Pipeline Safety Revolving Fund. This check should satisfy compliance with Condition 39 for the fiscal year ending April 30, 2020.
