

SRP HEAT PUMP WATER HEATER REBATE PROGRAM

A. CONTRACTOR TERMS AND CONDITIONS AGREEMENT

- 1. To qualify for an SRP Heat Pump Water Heater Rebate, the installing contractor must complete the Contractor/Installer and Heat Pump Water Heater Information sections of the rebate application.
- 2. Replace the existing water heater with a new ENERGY STAR® certified heat pump water heater (HPWH) that meets minimum efficiency ratings with a Uniform Energy Factor (UEF) of 2.8 or better. Visit the ENERGY STAR Find and Compare Products webpage at energystar.gov/productfinder/product/certifiedwaterheaters to locate an HPWH that meets the specific program requirements.
- **3.** Install the HPWH in a home that has had permanent electric service from SRP for more than one year. Rebates are not available for new construction.
- **4.** Failure to provide any of the required information, including signatures, will result in the return of the rebate application. The rebate application must be submitted within six months of the installation date.
- 5. SRP reserves the right to inspect the installation of the HPWH for compliance with the program requirements. If the HPWH is selected for an inspection, the rebate will be withheld pending the outcome of the inspection. If the HPWH is found to be in compliance, the rebate will be paid. If the HPWH is not in compliance, the customer and contractor will be notified. To qualify for the rebate, the customer is responsible for negotiating with the contractor to bring the HPWH installation into compliance. A reinspection using SRP's authorized inspectors must be completed and submitted to SRP. The contractor is responsible for the expense of a re-inspection. SRP will process the application after receiving the re-inspection documentation.

- **6.** Program procedures, requirements and rebate levels are subject to change or cancellation without notice.
- 7. One rebate check will be issued per approved application to the person listed as the customer of record on the SRP account. If the customer agrees to release the rebate to the contractor, the contractor will receive the rebate.
- 8. SRP makes no representations and provides no warranty or guarantee with respect to the design, manufacture, construction, safety, performance or effectiveness of the HPWH, including any warranties of merchantability or fitness for a particular purpose. The contractor selected by the customer is solely responsible for the proper installation of the HPWH as well as the delivery and workmanship related to any equipment or services the customer procures. The customer is responsible for the selection and supervision of the contractor to ensure that the contractor complies with the requirements of the SRP Heat Pump Water Heater Rebate Program. SRP assumes no responsibility for the quality or oversight of contractor services.
- 9. The Terms and Conditions set forth herein constitute a complete statement of the Terms and Conditions applicable to this promotion and supersede all prior representations or understandings, whether written or oral. SRP shall not be bound by or liable for any statement, representation, promise, inducement or understanding of any kind that is not set forth herein. SRP reserves the right to change or cancel this promotion or its Terms and Conditions at any time.
