**BEFORE THE ARIZONA POWER PLANT AND

4 In the matter of the application of Salt River
5 Project Agricultural Improvement and
6 Power District, in conformance with the
7 requirements of Arizona Revised Statutes §
8 40-360, et seq., for a Certificate of
9 Environmental Compatibility authorizing
10 the South Mountain Transmission Project,
11 which includes the construction of two new
12 230 kV double-circuit transmission lines
13 that will interconnect the existing double-
14 circuit Anderson-Orme transmission line to
15 a new substation, each located within the
16 city of Phoenix, Maricopa County, Arizona.

NOTICE OF HEARING

12 **A PUBLIC HEARING WILL BE HELD** before the Arizona Power Plant and
13 Transmission Line Siting Committee (“Committee”) regarding the Application of Salt
14 River Project Agricultural Improvement and Power District (“SRP” or “Applicant”) for a
15 Certificate of Environmental Compatibility (“Certificate”) authorizing the construction of
16 the South Mountain Transmission Project (“Project”). The Project will consist of two
17 new double-circuit 230 kV transmission lines that will interconnect the existing double-
18 circuit Anderson–Orme 230 kV transmission line to a new 500/230/69 kV substation
19 (“New Substation”). A map of the Project is attached as Exhibit A.

20 The hearing will be held at the Vee Quiva Resort & Casino, located at 15091
21 South Komatke Lane, Laveen Village, Arizona 85339, commencing on Tuesday,
22 November 12, 2024, at 10:00 a.m., and will continue each weekday through Wednesday,
23 November 20, 2024, as necessary, at the same location beginning at 9:00 a.m. on each
24 day, unless a tour is taken. If any revisions to the hearing schedule are required, they will
25 be noticed on the Project website at <https://www.srp.net/smt> and on the Arizona
26 Corporation Commission (“Commission”) website at [https://www.azcc.gov/arizona-
power-plant/meeting-schedule](https://www.azcc.gov/arizona-power-plant/meeting-schedule).

1 PUBLIC COMMENT WILL BE TAKEN IN A SPECIAL EVENING
2 SESSION ON TUESDAY, NOVEMBER 12, 2024, AT 5:30 P.M., VIA
3 TELEPHONE, ZOOM, OR IN PERSON AT THE VEE QUIVA RESORT &
4 CASINO, LOCATED AT 15091 SOUTH KOMATKE LANE, LAVERN VILLAGE,
5 ARIZONA 85339. PUBLIC COMMENT MAY ALSO BE TAKEN AT OTHER
6 TIMES DURING THE HEARING AT THE DISCRETION OF THE CHAIRMAN
7 OF THE COMMITTEE.

8 PLEASE BE ADVISED THAT ALL LOCAL AND STATE PUBLIC
9 HEALTH AND SAFETY GUIDELINES WILL BE FOLLOWED DURING THE
10 PUBLIC HEARING AND PUBLIC COMMENT SESSION. RESTRICTIONS ON
11 PUBLIC ACCESS, SAFETY PROTOCOLS, AND REVISIONS TO THE
12 HEARING SCHEDULE MAY OCCUR DUE TO PUBLIC HEALTH
13 CONSIDERATIONS.

14 THE PUBLIC HAS THE OPTION TO PARTICIPATE BY EITHER
15 WATCHING THE MEETING ONLINE OR LISTENING TO THE MEETING
16 VIA TELEPHONE. At least 24 hours in advance of the hearing, information regarding
17 online and telephone hearing access as well as any additional details regarding safety
18 protocols or other revisions to the hearing schedule will be posted on the Applicant's
19 Project website at <https://www.srp.net/smt>.

20 The Chairman may, at his discretion, recess the hearing to a time and place to be
21 announced during the hearing, or to be determined after the recess. The date, time, and
22 place at which the hearing will be resumed will be posted on the above-noted Project and
23 ACC websites. **NOTE: NOTICE OF ANY SUCH RESUMED HEARING WILL BE
24 GIVEN; HOWEVER, PUBLISHED NOTICE OF SUCH A RESUMED HEARING
25 IS NOT REQUIRED.**

26 If a tour is taken, it will begin on Wednesday, November 13, 2024, at
approximately 9:00 a.m. or an alternative date and time set by the Chairman. A map and

1 itinerary of any such tour will be available at the hearing and posted on the Project
2 website at <https://www.srp.net/smt> and the Commission's website at
3 <https://www.azcc.gov/arizona-power-plant/meeting-schedule>. Members of the public may
4 follow the Committee on the tour. During the tour, the Committee may hear testimony at
5 stops on the tour concerning what is visible at stops and the relevance of the location and
6 view to the Project. No other discussion or deliberation concerning the Application will
7 occur during the tour. A court reporter or recording device will record any testimony
8 taken on the tour for transcription. Public health and safety protocols specific to the tour
9 will be included on the itinerary.

18 The Applicant will make available final copies of the pre-filing conference, pre-
19 hearing conference and hearing transcripts at each of the above locations and websites.

20 Each county, municipal government, and state agency interested in the Project that
21 desires to be a party to the proceedings shall, not less than ten (10) days before the date
22 set for the hearing, file a Notice of Intent to Become a Party with the Director of Utilities,
23 Arizona Corporation Commission, 1200 West Washington Street, Phoenix, Arizona
24 85007.

25 Any domestic nonprofit corporation or association formed in whole or in part to
26 promote conservation or natural beauty; to protect the environment, personal health or
other biological values; to preserve historical sites; to promote consumer interests; to

1 represent commercial and industrial groups; or to promote the orderly development of the
2 area in which the Project is located that desires to become a party to the proceedings
3 shall, not less than ten (10) days before November 12, 2024, file a Notice of Intent to
4 Become a Party with the Director of Utilities, Arizona Corporation Commission, 1200
5 West Washington Street, Phoenix, Arizona 85007.

6 The Committee or the Chairman, at any time deemed appropriate, may make other
7 persons parties to the proceedings.

8 Any person may make a limited appearance at a hearing by filing a statement in
9 writing with the Director of Utilities, Arizona Corporation Commission, 1200 West
10 Washington Street, Phoenix, Arizona 85007, not less than five (5) days before November
11 12, 2024. A person making a limited appearance will not be a party or have the right to
12 present testimony or cross-examine witnesses.

13 This proceeding is governed by Arizona Revised Statutes (“A.R.S.”) §§ 40-360 to
14 40-360.13 and Arizona Administrative Code Rules R14-3-201 to R14-3-220. Substantive
15 communication not in the public record may not be made to any member of the
16 Committee. The written decision of the Committee will be submitted to the Commission
17 pursuant to A.R.S. § 40-360.07. Any person intending to be a party to the proceeding on
18 the matter before the Commission must be a party to the proceeding before the
19 Committee.

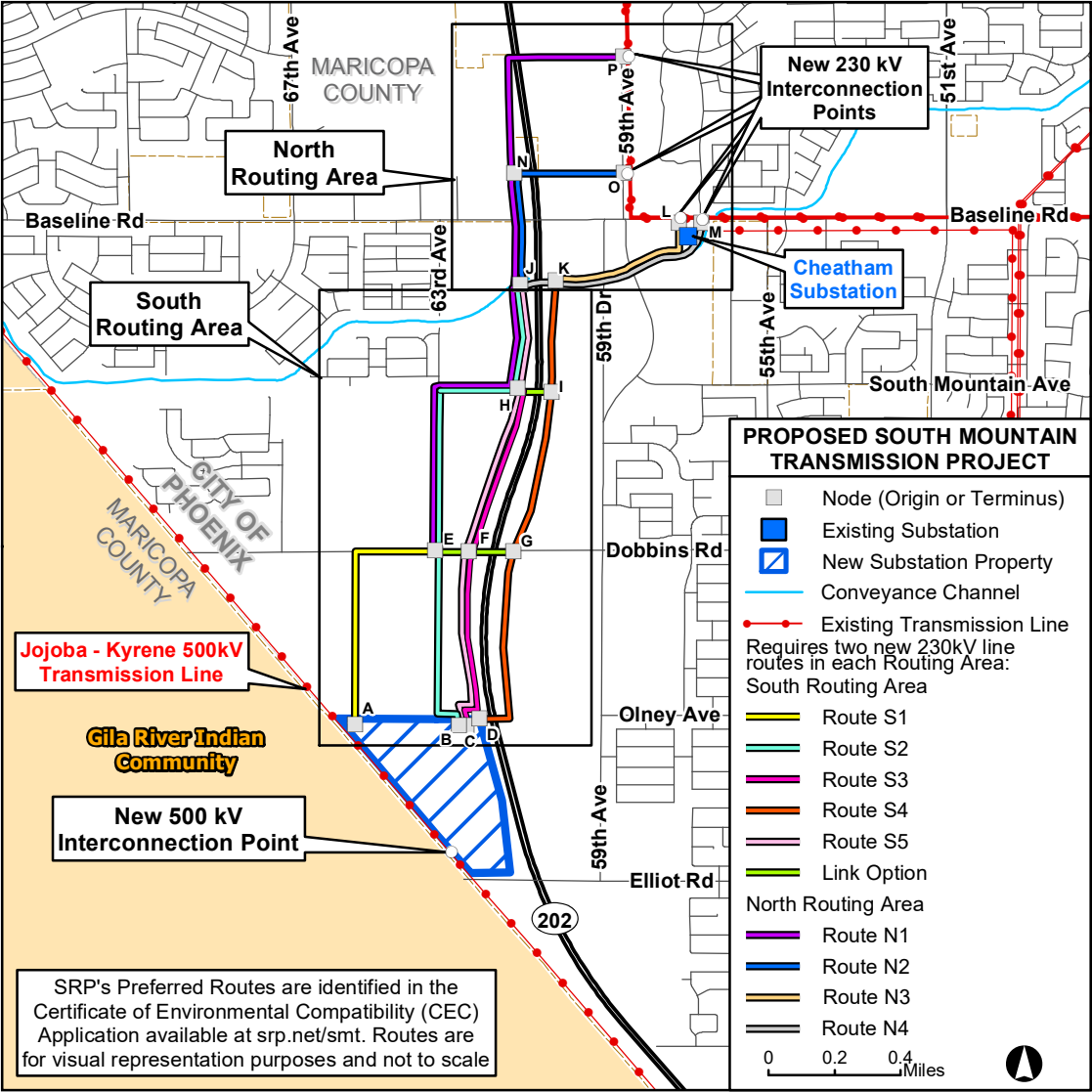
